## **Information Sheet on the Publication of an Electronic Doctoral/Postdoctoral Thesis via the Publication Server Share\_it**

The publication of the full-text version of the doctoral or postdoctoral thesis is based on the Share\_it platform in the electronic exchange format PDF/A, which is released in the OPAC of the University and State Library of Saxony-Anhalt in Halle and by an automatic notification to the German National Library.

### **The following requirements must be observed during submission:**

- The electronic version in PDF/A format must correspond to the print version.
- Personal information relevant to data protection must be removed (only applies to the electronic version). The pagination of the publication may not be changed by this. Removal/modification after publication is not possible.
- The file must not have any password and/or copy protection.
- The following metadata on the content must be submitted in Word format in the language of the work (for cumulative works in the language of the framework text):
  - an abstract with a maximum of 1,000 characters (including spaces);
  - a maximum of 10 keywords.
- 1 bound print copy - as hardcover binding and printed on non-aging, wood- and acid-free paper - must be submitted.
- For a cumulative thesis, the following regulations must also be observed.

### **Cumulative/publication-based thesis:**

- The consent forms of the publisher(s) to publish the whole or parts of the work shall be attached to this deposit licence.
- Those parts for which permission has not been granted must be replaced by a link to the full text and an abstract. The pagination of the publication may not be changed.
- If full texts are replaced by a link and an abstract, the electronic version is no longer identical in content to the print copy. In this case, according to the specifications of the German National Library (DNB), 2 further bound copies must be submitted for the delivery to the DNB in addition to the above-mentioned print copy.
